Dear member

If you're a member of either **CSC 2005** or **CSC Main Schemes (including the SMS section)**, we want to merge these two into one in order to simplify and maximise the efficiency of the schemes. So to make it easier for everyone to understand, the combined scheme will be known as the **DXC Pension Plan**.

But you can rest assured, although the name of the pension schemes may change, most other aspects of your scheme will remain unchanged as a result of the merger.

Unchanged: Accrued benefits

If the merger goes ahead, you won't have to do anything different. All the benefits (e.g. defined benefit pension, defined contribution funds, additional voluntary contributions, death benefits) you've already built up in your existing pension scheme will remain unchanged, as will any current level of contributions.

Unchanged: Your administration provider and support service

Whoever you normally contact to discuss your pension or to help manage any of your questions or queries will also stay the same under our new proposals. So there's no need to change any of the details you have stored in your smartphone, diary or computer.

Here are some key dates for you to bear in mind:

From 10 June 2020 to 9 August 2020

We were only required to hold a formal consultation with active members of the Defined Contribution sections of the CSC Main Scheme. This started on 10 June 2020 for 60 days but the full membership were encouraged to ask questions and give comments. The consultation is now complete and following agreement between the Company and the Trustee, we are now moving forward with the merger.

October 2020

As we go through operational matters, which is likely to take a few more weeks, the new proposed date for the merger will be on or around the 12 October 2020. In the meantime, we still welcome any questions, so please email enquiries@dxcpensionplan.com.
