Dear member

As a member of the Xchanging Defined Benefit Pension Scheme (XDBS Scheme), DXC Technology are writing to you to as the sponsoring employer for the scheme to explain some important changes that we would like to make.

DXC Technology currently supports a number of pension schemes, including the XDBS Scheme. Following a strategic review of the Company's pension arrangements, the decision has been taken to combine a number of the schemes into a single larger scheme, the CSC Computer Sciences Ltd 2005 Pension Scheme (CSC 2005 Scheme). This change (known as a merger) will simplify and help maximise the efficiencies of the running of all the Company's schemes.

The Company has discussed the proposed merger with the XDBS Scheme Trustees and has received the approval of the Trustees to merge. In agreeing to merge, the XDBS Trustees carefully reviewed the rationale for the proposed merger, and having discussed the proposal with their advisers, concluded that the merger was in the best interests of members.

Importantly, the merger will not impact your benefit entitlement under the XDBS Scheme and further details on what the merger means for you can be found in this pack.

Once the merger has taken place, it is proposed that the name of the merged scheme will change to the **DXC Pension Plan**.

You can rest assured that although the name of the pension scheme may change, most other aspects of your pension scheme will remain unchanged as a result of the merger. In particular, there will be no change to the employers who are currently responsible for funding the XDBS Scheme and all existing contribution and funding arrangements will remain in place until the next scheduled actuarial valuation of the merged scheme, due on 30 June 2021.

UNCHANGED: ACCRUED BENEFITS

All the benefits you've already built up in your existing pension scheme will remain unchanged. These include defined benefit pension, additional voluntary contributions and death benefits.

UNCHANGED: YOUR ADMINISTRATION PROVIDER AND SUPPORT SERVICE

Whoever you normally contact to discuss your pension or to help manage any of your questions or queries will also stay the same under our new proposals. So there's no need to change any of the details you have stored in your smartphone, diary or computer.



CHANGING: THE NAME OF YOUR PENSION SCHEME

As no formal consultation is required, we are writing to notify you that the name of your pension scheme will change to:

As a result of the scheme merger, the XDBS Scheme's Trustee Board will be replaced with the Trustee Board of the new DXC Pension Plan. The DXC Pension Plan Trustee Board is experienced and knowledgeable, and will be subject to the same requirements in ensuring that the DXC Pension Plan is run in a compliant and professional manner. It is also worth noting that two of the current XDBS Scheme Trustees are already members of the CSC 2005 Pension Scheme Trustee Board.
